10. Verification of Distribution – Mail and Carrier Delivery Distribution

Green Banner Publications did not report mail distribution during the audit period. Mail distribution is verified through the review of mail statements and/or additional publisher support documents. Green Banner Publications reported an average carrier delivery distribution of 59,467 during the audit period. Carrier delivery is verified through the review of carrier statements and/or additional publisher support documents. The Circulation Verification Council performed a delivery & readership verification in the primary market areas indicated in paragraph nine. Delivery verification is performed using multi-source methodologies considered necessary under the circumstances of the audit. Delivery verification can include, but is not limited to, residential and cell phone interviews, online surveys, email surveys, USPS surveys, in-person interviews and/or social media surveys. Delivery verification source data can include, but is not limited to, residential phone listings, cell phone exchanges, delivery lists, opt-in email databases, online, and/or social media databases. The purpose of the verification is to substantiate receipt of the publication, and further identify individuals who read or look through the publication.

CVC review indicates that a sufficient number of individuals reported that they receive the (appropriate Green Banner Publication) on a regular basis to substantiate the publisher's distribution claims. CVC verification confirms that 617 of 639 individuals or 96.6% report they receive the (appropriate Green Banner Publication) on a regular basis.

CVC verification confirms that 488 of 617 or 79.1% report they regularly read or look through the (appropriate Green Banner Publication).

*Households reporting stop delivery requests were excluded from the survey.

The Circulation Verification Council estimates that all the information in this text box has a minimum accuracy level of +/-4%.

The Circulation Verification Council performed delivery verification in the primary market areas indicated in paragraph nine.
